Q1	My company is a staffing and recruitment firm. We recruit and staff medical professionals for our healthcare clients. Is Red Hook Residential Center looking to engage in a contract with a staffing firm or firm that provides actual healthcare services?
A1	All bidders who satisfy the requirements noted in sections 3.2 through 3.5 are eligible. Due to the nature of the requested services, locum tenen vendors and temporary staffing agencies are not eligible to bid on this procurement.
Q2	Why is the contract out for bid? Is it required to be put out for bid?
A2	The current contract for psychiatry services is ending 9/30/19. Psychiatry services is a required service that must be provided continuously in the facility.
Q3	Is Red Hook Residential Center satisfied with the current provider(s) of services?
А3	OCFS's satisfaction with the current vendor has no bearing on this procurement. The current provider is welcome to submit a bid if they choose to.

Q5	Are we required to submit pricing for all titles included in the RFP?
A5	There is one position for psychiatry services available at Red Hook Residential Center. An hourly rate is required with the bid submission.
Q6	What factors will Red Hook Residential Center be considering when making an award?
A6	The offeror meeting all the minimum qualifications stated in the IFB, passing vendor responsibility review and offering the lowest hourly rate for the location, will be awarded a contract.
Q7	How many vendors is Red Hook Residential Center planning on awarding?
A7	It is the intention of the State to award a single contract to the awarded offeror.
Q8	If more than one, will there be primary, secondary, tertiary, etc. status for vendors?
A8	It is the intention of the State to award a single contract to the awarded offeror.
Q9	If more than one firm is awarded and there isn't a tier system, how will jobs get distributed to firms?
A9	It is the intention of the State to award a single contract to the awarded offeror.
Q10	How many Psychiatrists does Red Hook Residential Center need?
A10	There is one position available at Red Hook Residential Center.

Q12	Typically, how long are the assignments?
A12	The preferred candidate must be available for the start date of the contract resulting from this
	procurement. Due to the nature of this service, the same candidate must be available for the
	duration of this contract to provide consistency for the youth in OCFS care. The contract
	period for this IFB will be for a three (3) year period.
Q13	How many hours did this title work in 2016, 2017, and 2018?
A13	This information is not readily available. A FOIL would be required for this information.
Q14	What was the spend on this contract in 2016, 2017, and 2018?
A14	This information is not readily available. A FOIL would be required for this information.

	the minimum qualifications, passing vendor responsibility review and offering the lowest
	hourly rate for the location will be awarded a contract.
