SUBJECT: Comprehensive Medicaid Case Management (CMCM) - Enrollment of Office of Mental Retardation and Developmental Disabilities (OMRDD) State-Operated Borough/Developmental Disabilities Services Offices (B/DDSOs) in MMIS.

ATTACHMENTS: There are no attachments to this LCM.

In March, 1990, you received 90 LCM-36 which described Comprehensive Medicaid Case Management (CMCM) services provided through the Office of Mental Retardation and Developmental Disabilities (OMRDD).

According to the approved OMRDD CMCM proposal and State (Medicaid) Plan Amendment, providers of OMRDD CMCM shall only be the Borough/Developmental Disabilities Services Offices (B/DDSOs) of OMRDD and agencies and organizations so designated by OMRDD.

Previously, only "voluntary" agencies have been enrolled in MMIS with local district WMS registration/termination responsibility and a 25% local share for the at-home population unless the client is exempt from a local share because of Overburden.

This memorandum is to announce the MMIS enrollment of the State-operated B/DDSOs as CMCM providers. Local districts must complete the WMS registration/termination procedures in the Restricted Recipient/Exception Subsystem described in 90 LCM-16 to facilitate program services to the clients served by B/DDSOs. OMRDD, through its Revenue Management Field Offices (RMFOs) will provide you with a list of clients authorized to participate in OMRDD CMCM for registration purposes. Although clients served by the B/DDSOs include local district clients, there will be no local share.
